### **New Hires:**

Maggi made a motion to approve the hiring of Joseph Sapia and Jared Cutler to be hired as Public Works employees. No discussion. Approved unanimously.

## Set a Town Meeting:

Maggi made a motion to set a Town Meeting to a grant driveway and utility easement across Town Property adjacent to lot #12, 141 Silverspring Drive, Property of Dante Ursini. No discussion. Approved Unanimously.

Bill Warner, Town Planner made a presentation regarding different options that can be taken once Swan Hill is donated.

Milardo made a motion to call a Town Meeting accept the of Donation of Open Space Acreage (Swan Hill) from Regional School District 17 for the value of \$1.00 (adjacent to Haddam Elementary School Property) based on Bill's option 1 per approval of Planning and Zoning. Approved unanimously.

Schlag made a motion per agreement of the Haddam Land Trust for the Town of Haddam to donate that same property to the Land Trust for the value of \$1.00. Approved unanimously.

# Haddam Elementary:

There was a discussion regarding the purchase of Haddam Elementary and how much the building could be purchased for.

Schlag made a motion to have a Public Hearing to discuss the purchase of the building & the remaining 10 acres. Milardo Seconded. There was a brief discussion. Motion is amended: to schedule it the same date of the Town Meeting for the Swan Hill Donation the week of April 22nd. Approved unanimously.

## **Public Comment:**

Lundgren, Mark: commented that the Haddam Neck "Squad" Fire Truck came from Haddam (it is a stick shift) and Haddam Neck can drive it. He also commented that the Capital Plan has the replacement of Fire Department parking lots - Haddam Neck's parking lot cannot wait - there are 3 pot holes in it.

Rizzo, Joe: Commented if Haddam already owns 58% and Killingworth 40% can Haddam pay that money to Killingworth?

Luisi, Dan: commented that the Board of Education sell HES and the town stay out of it.

Perron, Neal: Asked if Ague Spring Land also or just Ague Spring Road? He also asked if Eversource paid for Quarry Hill Road, Milardo stated Eversource was paying for Cove Road. He also commented that the Senior Van posting stated the applicant needed a CDL with a class B or C. To drive the Senior Van in Haddam, which is registered as a service bus, you need a F Endorsement.

McGarry, Robert: commented that the "Squad" Firetruck came to Haddam Neck Fire Department is able to try out this truck without having to purchase it.
