Call to Order/Pledge of Allegiance

Chairman Centofanti called the meeting to order at 6:30 pm

The Pledge of Allegiance was recited.

Seating of Alternates:

Fredericksen made a motion, seconded by Lundgren to seat Challenger. No discussion. The motion carried unanimously.

Approval of Minutes:

Lundgren made a motion, seconded by Challenger to accept the March 18, 2019 minutes. No discussion. Motion carried unanimously

Challenger made a motion, seconded by Fredericksen to accept the March 25, 2019 minutes. No discussion. The motion carried.

Moriarty made a motion, seconded by Lundgren to accept the April 1, 2019 minutes with spelling correction. Motion carried unanimously.

Public Comment:

Schlag: Made a comment regarding the Board of Education meeting that occurred last week. Three times the BOE stated Haddam does not want HES for free. Schlag is concerned for the lack of communication between all boards.

Finance Directors Report:

Selectmen's Report: State awarded the Town of Haddam \$175,000.00 toward Scovill Hoe. (Brownfield Grant)

BOE met on Thursday, April 11, 2019. They decided to donate Swan Hill directly to the Haddam Land Trust. There was discussion on how the boundary lines would be set. The Town Planner is working on a deed based on natural land divides.

The Board of Selectmen voted today to request \$450,000.00 to be paid to RSD17 over three (3) years. The Selectmen set a Public Hearing for May 1, 2019 at 6:30 pm at the Firehouse and then set a Referendum for June 4, 2019.

It was suggested that all options and costs affiliated with those options be offered to the voters at the public hearing.

Moriarty made a motion, seconded by Lundgren, to approve up to \$450,000.00 to purchase Haddam Elementary School from RSD17 by going to a Public Hearing & Town Meeting with payments starting July 1, 2020 over a three (3) year period. There was a brief discussion. Motion carried unanimously.

Shall the Town of Haddam purchase from the Regional School District No. 17, the Haddam Elementary School building and surrounding 10 acres, more or less, for the purchase price of \$450,000.00 to be paid to the Regional School District No. 17 over a three-year period in equal annual installments starting in FY 2021?

New Business:

Review and discussions of the 2019 – 2020 Budget:

095 – Insurance/Benefits: Fredericksen made a motion, seconded by Challenger to approve \$1,230,577 Insurance & Benefits (095). No discussion. Motion carried unanimously.

Capital Plan: There was a lengthy discussion regarding the Fire Departments and Public Works equipment. There was discussion regarding the roads and the growing number.

There was discussion regarding infrastructure and the Connectivity Grant – The grant does not pay for engineering and design. The town will do \$400,000.00 worth of sidewalk. The engineering & design is going to cost \$70,750.

Debt Service: There was discussion regarding the amount to fund. Fredericksen made a motion, seconded by McGarry to put \$575,000 in the debt service. Moriarty, Challenger Yay, Lundgren Abstained. Motion carried.

Capital Budget: Fredericksen made a motion, seconded by McGarry to put into the Capital Budget for this year items listed on the Bond Financing Plan worksheet (attached as schedule 1) as well as the two Fire Trucks for a total \$7,007,250.00 7 million in Bonds and the capital budget for \$585,000.00. Fredericksen, McGarry and Challenger Yay, Moriarty and Lundgren Nay. Motion Carried.

Contingency: There was brief discussion regarding the amount. Fredericksen made a motion, seconded by Challenger, to fund Contingency with \$50,000.00. No further discussion. Motion Carried Unanimously.

Public Comment:

Schwing: made a comment regarding the Debt Service and the Capital Plan.

MAN MADE COMMENT: made a comment regarding the closing of Haddam Elementary School and the Referendum questioned if the redistricting does not go as planned, what are the costs to renovate Burr Elementary School.

Fredericksen made a motion seconded by Challenger to adjourn the meeting at 8:26 pm. Motion carried unanimously. Minutes taken by JoAnn Ricciardelli, Recording Secretary.
