Call to Order/Pledge of Allegiance

Chairman Centofanti called the meeting to order at 6:30 pm The Pledge of Allegiance was recited.

<u>Seating of Alternates:</u> Fredericksen made a motion to seat Challenger for Lundgren. Haase seconded. No discussion. Motion carried unanimously.

<u>Approval of Minutes</u>: Fredericksen made a motion, seconded by Challenger to accept the September 16, 2019 minutes. There was a brief discussion to correct "charger" to Charter. Under Selectman's request for Public Visioning Grant correct who made the motion Fredericksen made the motion and Moriarty seconded. Under new business change the \$338,000 to \$700,000. No further discussion. Motion carried unanimously.

Public Communications: Tax Collector's Report was passed around.

Centofanti stated he would answer questions raised during the last meetings public comment at the end of the meeting.

Adams, Maurice: Presented Centofanti with a letter with questions regarding the Town revenue budget

Aronow, Alan: Commented that the 9/16/19 minutes under Public Comment were made by Alan Aronow not Alan Alonzo.

Finance Director's Report:

Mira will not be sending a recycling rebate this year.

20-21 Budget Documents are being prepared.

Budget Transfers:

Haase made a motion, seconded by Fredericksen to approve the Interdepartment Transfers for Fiscal year 2019 dated 10/17/19. (Attached as Schedule 1) There was a brief discussion regarding Solid Waste Disposal. No further discussion. The motion carried unanimously.

Fredericksen made a motion, seconded by Challenger to approve the Intradepartment transfers in the amount of 10,828.00. (Attached as Schedule 2) No discussion. The motion carried unanimously

Moriarty made a motion, seconded by McGarry to approve the budget Transfers in the amount of 1,122,000.00 (Attached as Schedule 3) to go to Town Meeting. No discussion. The motion carried unanimously.

Fredericksen made a motion, seconded by Haase to approve transfer request form 2020-3 to go to Town Meeting. (Attached as Schedule 4) No discussion. Moriarty, Challenger Yay. McGarry abstained. The motion carried.

Fredericksen made a motion, seconded by Haase to approve transfer request 2020-4 to go to Town Meeting. (Attached as Schedule 5) No discussion. The motion carried unanimously.

Selectman's Report: Milardo provided the Board with the list of roads that will be done with the Bonding money. Dublin Hill Bridge should be done in the middle of December. Tap Grant/Sidewalk Grand are both ready to go. Water is moving along. All road work that is not done yet will be done by the end of October.

Old Business:

Centofanti discussed the following in response to questions asked in public comment in the previous meeting: Town Aid Roads are budgeted in the capital and non-recurring fund as determine in budget process. There is not a lack of transparency. This was changed to be fiscally conservative and responsible given the State lack of stability in fund grants. If monies are received they are spent on road in accordance with State grant requirements.

LOCIP is also budgeted in the Capital Fund as the grant relates to the Town's approved capital plan.

In the future we will make it clear in the budget document and we will provide the Board monthly a capital and nonrecurring revenue report in addition to the expenditure report that is currently provided.

Bonding: With respect to items included in the capital plan and bonding package, the specific items are approved (plow truck, backhoe) not the make and model. That would be determined through the bid process or the State bid. We will ensure in the 20 - '21 capital plan that the items are not identified by make or model.

State Statutes are applicable to Town's that do not have charter. When a Town has a charter, the State Statutes apply if the charter does not address a particular item

Finally, the estimated fund balance at June 30, 2019 will be will change based on proposed transfers that were approved tonight.
