- **Municipal Agent for the Elderly:** Assisted in person or on the phone 33 people. She had a client get awarded \$2,500.00 for dental work from Soldiers, Sailors & Marines. They are also helping him with food, electricity and oil. The issue with CRT and Meals on Wheels has been resolved. There is not a waiting list at this time and there shouldn't be in the future. There was a meeting at High Meadow with HUD. There are improvements that need to be done. Coordinating with a contractor has been difficult. High Meadow needs a Board of Directors. They need a minimum of 7 people. Right now they have 2 board members so they do not have a quorum. Anyone interested please let us know.
- **Resident Trooper:** March there were 599 calls in April there were 534 calls. There were some cars stolen recently. They are looking into that. The fraudulent letters that were sent out

representing to be the Assessor's office – someone has confessed. They are still working on the nails on 154 going from Middletown to Chester. If anyone has any information please contact our office.

- Senior Center: Thank you to Jack Murphy for providing meals to our seniors. CRT still does not have a permanent person working at the center to serve the food. They are looking for someone. For July and August the Center will serve meals on Monday, Wednesday and Friday. Stay tuned for more information. We are very grateful to everyone who has volunteered their time and money to the Senior Center. Thank you to Suzanne! Diane Gondek the Senior Van Driver had a total of 77 passengers. 19 of them were medicals.
