Correspondence: Milardo read a letter from the Brainerd Memorial Library *Dear Lizz*,

Writing for the Board of Trustees, I would like to thank the Town for contributing \$12,950 towards the purchase of a new boiler for the Library.

The new boiler and associate installation cost the Library \$27,250, so the Town's contribution was extremely beneficial in providing part of the necessary funding. We look forward to the anticipated 25% fuel oil savings and associated decrease in electric usage, which will create capacity in other sectors, and help to keep more level our operational needs.

I think this is another successful "joint venture" between the Town and the Library. In addition, let me take this opportunity to formally thank you for sending us a free Verizon cell phone signal booster, which provides greater safety and convenience for patrons in and around the library. The response has been very appreciative.
