#### b) Open Space

Mrs. Reynolds reported the Haddam Land Trust (HLT) was the sole bidder at the tax sale of a 10 acre parcel on Route 154 in Tylerville. The HLT will have to wait six (6) months before the sale is final.

Mrs. Reynolds also reported the HLT has been contacted regarding the donation of a 20 acre parcel on Chamberlain Hill Road. Bill Cowan, President, and Cindy Sullivan, Board of Director, of the HLT have reviewed the site.

## c) Budget

Mrs. Reynolds reported she had received emails pertaining to the 2023-2024 budget and the 2021-2022 Annual Town Report. Mrs. Reynolds also reported the Commission has funding in the current fiscal year's budget. Mrs. Reynolds stated she felt the Commission wasn't able to accomplish very much this past year.

Mr. Worthley stated in terms of accomplishing things he has heard state and federal people talking about climate funds, infrastructure funds, and Inflation Reduction Act funds coming down the pipeline. Mr. Worthley also stated if someone could sort out and figure out what the time lines are and who the entities are that are eligible for various the funds, there's an opportunity to do a project.

Mrs. Reynolds spoke in regard to American Rescue Plan Act (ARPA) funds and how the Chester Land Trust and the Town of Chester are working together to obtain funds. Discussion followed in regard to there being so much that could be done, but people need to found who will commit to doing the work. Also discussed was the hiring of interns; however, a number of other agencies are competing to hire the same people for summer internships and seasonal people. Mr. Worthley stated the labor market will be competitive.

Mr. Worthley stated he attended the Connecticut Urban Forest Council Conference and Forest Forum today and Katie Scharf Dykes, DEEP Commission, spoke about a number of funding streams. Mr. Worthley stated the program was good and the meeting came off very well.
