# Dear Board Member,

I would like to make two suggestions regarding traffic, one in Higganum and the other in Tylerville.

Heading north out of Higganum Center on Rt. 154 there have been a number of accidents with vehicles leaving business establishments and on coming traffic. The accident which happened last week prompts my request to use the Town's Traffic Speed Trailer in both directions in the vicinity of Higgies and Dunkin's. Moving it maybe every other week to keep it noticeable.

The use of the Trailer a while back where traffic was coming into the Center from the south on Rt. 81 was successful. Unfortunately it was never used in the opposite direction where most of the speeding occurs. Maybe it can be used again with the possible mixing time between Rt. 154.

My second request is to ask the State DOT to put off the construction of the "Round-a-Bouts" in Tylerville. The first at the intersection of Rts. 82 & 154, and the other at the Rt. 82 Connector to Rt. 9 & 154. Starting soon will be the Town's Sidewalk Project on Rt. 82, Bridge Road and then the huge Rehabilitation and Sidewalk Project on the Swing Bridge. Adding to this are two Bridge Replacement Projects. The first is on Rt. 82 in East Haddam and the second on Rt. 154 just north of Haddam's town line.

My point being that there is just too much road construction going on at once. A pause of a year after all this construction is completed would be a more reasonable time to build the "Round-a-Bouts" in Tylerville. Additionally, does anyone have the confidence in the State DOT to complete all these projects on time with all the Infrastructure Projects in progress all over the State?

My first request can be started tomorrow, my second request can only happen if all of us get behind it.
