Resolutions – Grant Approvals

CT River Gateway Commission Funding Request.

Whereas the Town of Haddam, CT is interested in applying for a \$10,000 grant through the CT River Gateway Commission; and

Whereas the Town shall use said funds to design and placement of entry signage which not only identifies and welcomes visitors to the cove but also explains the rich environmental features of the area and its industrial past.

Now therefore be it resolved that the Haddam Board of Finance approve the submittal of the application and authorize the First Selectman Robert McGarry to sign, submit and administer this grant application and award.

McCann property Purchase – Higganum Cove

Whereas the Town of Haddam, CT has signed a purchase and sale agreement for the McCann property in the Higganum Cove area for \$21,000. The contract includes 90 day due diligence and necessary approvals including Town Meeting.

This is a quarter acre parcel of land with frontage on Cove Wharf Road. Cove Wharf Rd. is the road that runs from Dublin Hill at the bridge all the way to the CT River.

The Board of Selectman have approved and recommend the Town acquire this parcel in order to preserve open space and avoid any development in the Cove area that could impact the Town's plans for the recreational activities in Cove area.

Now therefore be it resolved that the Haddam Board of Finance approve the purchase of the McCann property for \$21,000 and send the project to Town Meeting for approval.

Affordable housing Grant for Thriving Connecticut Communities Program

Whereas the Town of Haddam, CT is interested in applying for a \$15,000 grant through the State Department of Housing's Planning Grants for Thriving Connecticut Communities program; and

Whereas the Town shall use said funds to study the current status of affordable housing in Haddam, its land use regulations and various strategies to increase the affordable housing stock in the community.

Now therefore be it resolved that the Haddam Board of Finance approve the submittal of the application and authorize the First Selectman Robert McGarry to sign, submit and administer this grant application and award.

Resolutions – Grant Approvals

Department of Economic and Community Development Grant

Whereas the Town of Haddam, CT has submitted a grant application \$1,870,000 brownfield remediation grant through the State Department of Economic and Community Development.

The remedial estimates for this project are contingent on DEEP approving Remedial Action Plan and what will be required by DEEP's Ecological Risk Group for remediation of Candlewood Hill Brook. The Town intends to ready the on-site buildings for occupancy immediately so that revenue can be generated that can be used to further adaptive reuse initiatives for the site.

While the reuse concept does not specifically indicate the type of tenant, the Town believes that there is potential for maker space related to manufacturing, digital media, technology & innovation, or even financial services. The plan is contemplates that the 19,000 sq. of space will create an estimated 20-30 jobs.

Now therefore be it resolved that the Haddam Board of Finance approve the project authorization at \$1,870,000 and send the project to **Town Meeting** for approval.

Small Town Economic Assistance Program (STEAP) Grant

Whereas the Town of Haddam, CT has received approval for \$128,205 STEAP grant through the State Department of Office and Policy and Management

Whereas the Town shall use said funds for Higganum Community Sewer Project - Plan and design of community sewer design/engineering only (no construction).

Now therefore be it resolved that the Haddam Board of Finance approve the project authorization at \$128,205 and send the project to **Town Meeting** for approval.
