My last article focused on what was going on with our myriad projects in town. In this article, I want to look forward to fall events and chores.

While summer is busy with fairs, vacations and events that take us out of town, our focus in fall turns to events that happen in town. We had River Days in late September. Train Themed Decorations at the Thankful Arnold House Museum


Join us for a train themed holiday extravaganza at the museum with history, displays and shopping.

Board of Assessment Appeals

From January through March of each year, a window of opportunity opens for those of you who disagree with the town's assessment of your property, personal property declaration or a supplemental motor vehicle. This is the time when you may apply to appear before the Board of Assessment Appeals, who will decide whether your particular assessment should be adjusted. Here's what you need to know.

When you will need to apply: Applications will be available at the Assessor's Office or on-line beginning in mid-January. Your completed application must be received in the Assessor's Office, Tuesday, February 20, 2024.

When the hearings will be held: The Board of Assessment Appeals will hold hearings in March of 2024. You will be notified of the date and time of your appointment via a phone call. The Board will try its best to accommodate your schedule with daytime and evening appointments.

What you will need to attach to application: You should bring any evidence that supports your position i.e., a recent appraisal (not bank appraisal), invoices, contracts, photographs, maps, letters, etc. In addition, the Board may decide to schedule a site visit to see the property first hand.

What happens next: An Action Letter with the Board's decision will be sent to you within one week of your hearing.

Assessor's Corner Important Upcoming Deadlines

Active Members of the **U.S. Armed Forces**

Any active member of the United States Armed Forces (defined as United States Army, Navy, Marine Corps, Coast Guard, and Air Force, Space force and any reserve component thereof, including the Connecticut National Guard) is eligible for the exemption of one motor vehicle. Applications for the exemption must be completed annually and forwarded to the Assessor's office not later than the December 31st following the date on which property tax is due in the town in which the motor vehicle is registered. In other words, for the 2022 Grand List year the deadline is December 31, 2023. The forms are available in the Assessor's office and online on the Assessor's Page of the www. haddam.org website.

Farm, Forest or Open Space under Pub-

New applications for property owners claiming land as Farm, Forest or Open Space can be filed with the Assessor's Office between September 1st and October 31st, 2023. Please note that when filing for Forest Land, the application must be accompanied by a Certified Forester's Report which is due to the Assessor's Office no later than October 1st. The State's Forestry Department can provide a list of state foresters who can assist you. The Assessor's Office must review all applications, and accompanying reports, to determine if the property qualifies to be a part of the PA 490 Program.

Personal Property Declarations

Personal Property Declarations were mailed in late September. Any business owner not receiving a Personal Property Declaration should contact the Assessor's Office. Even though a declaration was not received by you, it does not preclude you from filing.

Notice is hereby given to all persons liable to pay Personal Property taxes in the Town of Haddam that they must return to the Assessor's Office, on or before the First day of November, their personal property list (declaration). Failure to declare will force the Assessor to estimate the value of the property and add a 25% penalty.

The personal property declaration shall include all furniture, fixtures, equipment and machinery of all commercial and industrial businesses; unregistered motor vehicles, snowmobiles, farm machinery and horses. Manufacturing Machinery Exemption and Farm Building Exemptions Applications must be filed at this time. Anyone claiming either of these exemptions must return the Declaration and Application by the October 31st deadline. A declaration received late, or not returned, will not be eligible for the exemption for the 2023 Grand List.

----IMPORTANT----

If you do not receive a Personal Property Declaration and you are operating a business in the Town of Haddam, it is your responsibility, according to Connecticut State Statutes, to file one. Failure to declare will force the Assessor to estimate the value of the personal property and add a 25% penalty. Once a penalty is applied to a Personal Property account, it cannot be

If you have received a personal property declaration and are no longer conducting business in Haddam as of October 1, 2023, you must complete the Affidavit on the front page of the declaration and return it to the Assessor's Office prior to November 1, 2032. This signed affidavit is mandatory as proof to allow the Assessor to remove you from the Grand List. If the documentation is not received it will force the Assessor to estimate the value of the personal property and apply a 25% penalty.

Defining a "Business"

There have been many questions raised over the past months regarding businesses and whether or not they should be picked up by the Assessor's Office. It is my hope that this article will help to explain and give some clarity.

The definition of a business is not easily conveyed in words because every situation is different and there are many aspects and questions that need to be asked in order to ascertain if a business should be listed with the Town.

Here are the ways we look at it; hopefully this will help answer any questions that you may have.

Do you provide a good or service in exchange for compensation? If you answered yes, then you are in a business.

There are a couple of ways to examine your individual situation to determine if you are a business or not. These are the most common aspects that we look to; and this list is not all-inclusive, but generally covers the most common aspects:

Advertising – If you are advertising, in print media, online, or in any other way, you are in business.

Amount of Time – It doesn't matter if you work at the business 3 hours a week, full-time, part-time, seasonally, or whenever someone calls to ask for you to provide a good or service to them. The number of hours, or time spent, doesn't factor into the determination on whether or not you are in business.

Assets – The amount of tangible business personal property also does not factor into the determination on whether or not you are in business. Business personal property can range from a hundred dollars for a part-time, home-based business, all the way up to millions of dollars (as is the case with most public utilities, and, in Haddam's case, the Connecticut Yankee property).

Compensation – The amount of compensation you receive also does not factor into the determination of whether or not you are in business. If you receive a 1099 for tax purposes, or you self-report your income to the IRS, you are in business. If you receive a W-2 from the business, then you are an employee and the business owner would declare the business personal property, not you as the employee (unless, of course you are an employee of your own company).

Home-Based Businesses – If you operate a farm, or make crafts for the local fairs, or are a CPA at home, you are in business. You are not required to rent or lease a space in order to be considered a business.

Income – The amount of money you make from your goods or services is irrelevant to determining whether or not you operate a business.

Ownership – If you have filed paperwork to be incorporated, or have created another legal entity (LLP, LP, LLC), then you are in business.

Rent a Space – If you rent/lease a space, then you are in business

Sales Tax – If you have a Sales Tax Certificate, or if you collect sales tax, you are in business.

Self-Employed – If you are self-employed and work for yourself, you are in business.

Trade Name Certificate – If you have filed a Trade Name Certificate with the Town Clerk, or have a Trade Name that you use for your operation, you are in business.



Updates from the Tax Office

The Tax Office has just mailed out all delinquent notices for Real Estate as well as Motor Vehicle. Personal Property delinquent bills were sent October 1, 2023.

If you have sold a vehicle or cancelled a registration notify the Tax Office or the Assessor's Office: DMV does not notify us of such changes. You could continue to receive a tax bill for a vehicle you no longer own. The sooner we can address the issue, the better.

If you require a clearance for DMV and you make an online payment, call the Tax Office and let me know. You will receive an email confirmation with the payment details. The online system does not automatically trigger a clearance. Online payments are not in real-time on our website and won't show until they are manually posted in the office.

If you have taxes for Motor Vehicle or Personal Property from prior tax years contact American National Recovery Group at 845-512-8444 to make a payment.

The Tax Office is open to the public Monday-Tuesday 8:30-4, Thursday 8:30-6 and Friday 8:30-12. Wednesday is by appointment only.

Commercial Vehicle Exemptions (M-65 MV)

CONNECTICUT GENERAL STATUTES \$12-81(74)

PROPERTY TAX EXEMPTION **INFORMATION**

A property tax exemption is available for certain commercial trucks, truck tractors, tractors and semi-trailers pursuant to CGS \$12-81(74). The exemption is available to two different classes of vehicles, depending their date of registration, GVW rating and use. Exemption eligibility is dependent on meeting all qualifying criteria for the class. The two categories of vehicle and qualifying criteria are listed below.

To qualify for the exemption for vehicles used to "transport freight for hire" (CGS § 12-81(74)(A)(i)), the following conditions must be met:

- The property for which the exemption is sought must be a new commercial vehicle, meaning that its equitable or legal title has never been transferred by a manufacturer, distributor or dealer to anyone other than the owner who files this exemption application, or the owner on whose behalf this application is filed.
- The vehicle's Gross Vehicle Weight Rating (or GVWR) must be in excess of 26,000 lbs.
- The vehicle must be used exclusively (i.e., 100% of the time it is used) for the interstate or intrastate transportation of freight for hire. The vehicle must be used by a "For Hire Motor Carrier". This means an individual or legal entity (such as a company or corporation) that is compensated for transporting freight belonging to an unrelated party. Freight is defined as merchandise or commercial goods having value. Anything discarded as worthless (for example, garbage or food wastes) is not considered freight. However, certain recyclable materials are freight, since they have value. See "Exceptions" below for exclusions from the definition of freight.

A vehicle used by a "Private Motor Carrier" is not eligible for this exemption. A "Private Motor Carrier" is a business that uses a vehicle to transport its own products to a wholesale or retail outlet, or a business engaged in renting vehicles for use by others. However, if the rented vehicle is used exclusively by a "For Hire Motor Carrier", it is eligible.

Exceptions: Although a vehicle may be used by a "For Hire Motor Carrier", the type of freight transported may make it ineligible for this property tax exemption. Such is the case with respect to the transportation of freight excluded from federal regulatory oversight (i.e., items listed as exclusions in Chapter 135 of Title 49 of the United States Code). Examples of such items include ordinary livestock; wood chips; broken, crushed or powdered glass; agricultural or horticultural commodities other than manufactured products thereof and natural or crushed volcanic rock to be used for decorative purposes. The Assessor(s) has a copy of the federal code

containing these exclusions.

To qualify for the exemption for vehicles with a GVW rating in excess of 55,000 lbs. (CGS § 12-81(74)(A)(ii)), the following conditions must be met:

- The property for which the exemption is sought must be a new commercial vehicle, meaning that its equitable or legal title has never been transferred by a manufacturer, distributor or dealer to anyone other than the owner who files this exemption application, or the owner on whose behalf this application is filed.
- The vehicle's Gross Vehicle Weight Rating (or GVWR) must be in excess of 55,000 lbs.
- The vehicle is not eligible for the exemption extended to vehicles under CGS \$12-81(74) (A) (i), as delineated above.

In order to receive either property tax exemption, an M-65MV application (accompanied by all required documentation) must be filed with and approved by the

Connecticut law allows you to receive an absentee ballot if you cannot appear at your assigned polling place on election day because of active service in the Military, absence from the town during all of the hours of voting, sickness, religious tenets forbid secular activity on the day of the election, duties as an election official at a polling place other than your own during all of the hours of voting, or physical disability. To receive your absentee ballot please complete and sign an application and return it to the Town Clerk's Office.

In person: at the Town Clerk's Office, 30 Field Park Drive, Haddam, during normal business hours.

NEW TO THE TRANSFER STATION*

The Board of Selectman recently passed a **new rule** increasing the Gross Vehicle Weight (GVW) from 10,000 lbs. to 14,500 lbs. If your vehicle falls between this new weight, new fee is \$150 Seniors \$75.

The Transfer Station is located on Route 154, just north of the Haddam Meadows State Park.



If you do not have a private trash collection service, trash and recyclables should be brought separated to the Transfer Station. To assure that only Haddam residents use the Transfer Station, a current Haddam Transfer Station Pass must be displayed in order to use the facility. Passes are good for the fiscal year (July 1 through June 30) and may be purchased for a \$100 for those under age 65; if you are 65 or older the fee is \$50.00. The passes are available at the Town Clerk's Office. LICENSE AND REGISTRATION ARE REQUIRED. CASH OR CHECK. The operators of the Transfer Station are licensed by the State and will assist residents to assure compliance with the recycling law.

Hours: Wednesday, 8:00 am-3:45 pm, Saturday, 8:00 am-3:45 pm, Sunday, 8:00 am-11:45 am.

To insure there is a clear understanding of the rules, please read below:

- Permit must be clearly displayed and adhered to the driver's side window shield.
- Registration must be written on the permit itself.
- Any vehicles without a current permit or without a sticker on vehicle will not be allowed to leave its contents at the Transfer Station.
- Transfer Station passes are required to be applied to the vehicle before use.
- Buy one get one. 50% off a second pass. There is a limit of two (2) Transfer Station passes per Haddam residence. This applies to the same household only. COMMERCIAL USE IS STRICTLY PROHIBITED. Anyone found violating this will be reported to the Resident State Trooper.

2023 SPORTS LICENSES are available at the Town Clerk's Office. The Department of Energy and Environmental Protection reminds anglers age 65 and older that the free resident fishing, hunting and trapping licenses for individuals age 65 and older became effective October 1, 2009. Assessor(s) of the town in which the vehicle is subject to property taxation. The three-digit number on the vehicle's registration (under Tax Town Code) indicates the town where the vehicle is taxed.

This exemption is available for five assessment years following the assessment year in which the vehicle is first registered. An application must be filed in order for the exemption to be granted. If there is no change with respect to the town in which an exempt vehicle is registered and there is no modification made to the vehicle since the initial application was filed, no application has to be filed for the balance of the exemption term after the exemption is initially granted.

If there is a change in tax town or modification to the vehicle since the initial application was filed, the timely filing of a new M-65MV, accompanied by the necessary documentation, is required.

Please contact the assessor(s) of the town in which the vehicle is subject to taxation if you have any questions concerning this application. Please note that the application deadline is November 1, 2023.


